USD

The U.S dollar on Friday hovered around its three-month low against a basket of major currencies and was set for a 1.2% weekly drop.

EUR

The dollar index was last down 1.002% after hitting its lowest point since Aug. 11, while the euro is up 1.12% to \$1.0522, hitting its highest level against the greenback since late June.

GBP

The sterling was last trading at \$1.2237, down 0.13% on the day. The pound advanced 1.7% overnight and touched a 5-month high of \$1.2311.

JPY

The dollar was 0.05% lower at 135.25 yen, having slipped as low as 135.045 yen earlier - the lowest since Aug. 18.

AUD

The Australian dollar dipped slightly to \$0.6796, after blowing past major resistance at 68 cents in the previous session, on Fed pivot hopes and China easing its zero-COVID policy.


CHF
