TERMS AND CONDITIONS

In consideration of People's Bank (Bank) pursuant to my request, making available to me Cash Deposit Machine (CDM) facilities and issuing to me Transit Card. I agree be bound the following terms and conditions

- 1. At all times to regard the Card as the property of the Bank and to surrender it unconditionally and without reservation upon demand by the Bank.
- 2. At no time to use or attempt to use the card unless there are sufficient funds in the card to cover the transaction.
- 3. To restrict use of the Card exclusively to the person named overleaf as it not transferable.
- 4. Not to use or attempt to use the Card after any notification of its cancellation or withdrawal has been given to me by the Bank or by any person acting on behalf of the Bank.
- At no time and under no circumstances to disclose to any Person the Personal Identification Number (PIN NO) allotted to facilitate the use of the Card in the Bank's ATM or any ATM where the card is accepted.
- 6. To immediately notify the Bank of the loss or theft of the LankaPay/ JCB 2 in 1 Card to cancel the Debit part of the Card. Bank cannot simply refund/ transfer available balance of transit components of any Loss or Stolen Transit Card (even LankaPay/ JCB 2 in 1 Card). Loss or Stolen Transit Card completely equivalent to the lost or stolen physical cash wallet.
- 7. Bank will not take any liability of transit transactions arising from lost or stolen cards for any remaining balance maintained in the card level.
- 8. In case of lost, theft or suspected misuse of Card, Bank shall have no responsibility. Bank shall not be responsible for any loss due to theft, misuse, fraud, etc... of the Transit Card. Customers are recommended to keep their Card in safe custody always. Applicant should always resolve any commuter disputes with relevant transport authority or its agencies.
- Further Bank cannot transfer or refund topped up money available in transit card account for any lost, stolen or suspected misused cards.
- 10. Event of loss the Transit Card, Bank cannot reissue the Transit card with remaining balance, since Transit Card transactions are offline and unable to trace the transactions. Instead of it is required requesting new Transit Card.
- Event of damage the Transit Card Bank will reissue the Card within 14 days after receiving all offline transactions. To reissue new card it should represent the damage card physically to the Bank.
- 12. I will accept the responsibility of all commuter/ off-line transactions originating from Transit Card/ Transit Card component of the card at all times.
- 13. Subject to (9) above to accept the Bank's record of withdrawals and/ or transfers as conclusive and binding for all purposes and to authorize the Bank to debit my account with all amounts withdrawn or transferred with or without my knowledge or authority.
- 14. Bank will be allowed the People's Bank Cash Deposit Machines to Top up the Transit card before use the card and once utilize the Transit Card up to LIKR 10,000 (for commuter card) or LIKR 50,000 (for conductor card)
- 15. To acknowledge that the amount stated on the CDM

screen or a printed deposit slip or receipt advice shall not for any purpose whatsoever be taken as conclusive of the state of my account with the Bank

- 16. Not to hold the Bank liable, responsible or accountable in any way whatsoever for any loss or damage howsoever arising caused by any malfunction or failure of the Card or the CDM or the insufficiency of funds in the ATM.
- 17. Notwithstanding and without prejudice to the generality of the provisions of (12) above the use of the Card shall be at my sole risk and I assume any and all risks incidental to or arising of the use of the card.
- 18. The Bank will not be responsible for the Card not being honored for any reason whatsoever.
- 19. The Bank shall not hold liable for any transaction disputes/ grievance arising from the use of transit card for commuter purposes. In the event of any dispute/ grievance with related commuter's journey shall be resolved with relevant Transport Authority or its agencies.
- 20. Subject to (18) above dispute handling will be handled by relevant Transport Authority or its agencies.
- 21. In the event of dispute or difference whatsoever arises between the parties concerning matters to this document or any provision hereof, parties in shall use their best endeavors to resolve the dispute of difference amicably.
- 22. That the Bank shall be at liberty to terminate the facility at any time without notice to me by cancelling or refusing to renew the Card.
- 23. All Transit Card Transactions be executed in Sri Lanka Rupees.
- 24. Transit Card should only be used for the offline local transit payments in LKR only.
- 25. The statement issued by the Cash Deposit Machine at the time of deposit will only represent what I purport to have deposited and shall not be binding on the Bank.
- 26. Other than the terms and conditions imposed by the bank on the usage of the card, the cardholder will also be abide by the rules and regulation imposed by Central bank Sri Lanka, JCB International (Japan) and Lanka Clear (PVT) Ltd on the usage of the card.
- 27. This document or any provision hereof shall be governed in accordance with Laws of Sri Lanka
- 28. With regard to the other charges wherever applicable will be added in future
- 29. Transit Card holders are only applicable to perform to Top up cash using People's Bank CDM machines and to perform LKR transactions via transit POS machines (offline)
- 30. The bank reserves the right to vary these terms and conditions.
