Terms and Conditions of "Dholos mahe Vaasi Chakraya"-Business Promotion Campaigns for 2025

1. "Ran Kaasi Vaasi"- Remittance Promotional Campaign

Methodology/Terms and Conditions

1.1 <u>Campaign Period</u>

The period considered for "Ran Kaasi vaasi" campaign is from 2025.01.01 to 2025.01.31.

1.2 Eligibility Criteria and Prize Details

- a) The top 3 customers who receive the highest value of Workers' Remittances during 2025.01.01 to 2025.01.31, directly into their People's Bank accounts (FC and LKR) will be selected and awarded a 22K gold coin each.
- b) Receiver /Beneficiary of a Remittance is eligible for this Draw.

1.3 **Selection of Winners**

The highest Inward Workers' Remittances value (Cumulative of the remittances received during the period will be considered) directly received to the People's Bank FC and LKR accounts by a single customer will be considered.

1.4 **Exclusions**

a) Remittances received via drafts, TCs, and currency notes are not eligible for this Business Promotional Campaign.

1.5 **Exclusion of Eligibility**

Inward Remittances received to staff accounts of People's Bank are excluded from this campaign.

1.6 **General Conditions**

- a) Workers' Remittances paid on each day of the week (including Saturdays and Sundays/ Bank holidays) will be considered as eligible remittances to select the winners for the draw.
- b) People's Bank reserves the right to disqualify any participant who does not comply with these terms and conditions.
- c) In the event of any dispute or clarification regarding the campaign, the decision of People's Bank management will be final.

2. "Nidahas Pranama"- "Ethera Udana" PFC Minors' Account Campaign

Methodology/Terms and Conditions

2.1 Campaign Period

The "Nidahas Pranama" campaign will be conducted from **2025.02.02 to 2025.02.08** (one week).

2.2 **Eligibility Criteria**

- a) Children whose parents (Mother and/ or Father) are already working abroad and sending remittances to Sri Lanka are eligible for this campaign.
- b) A new 'Ethera Udana' PFC Minors' Savings Account should be opened at a People's Bank Branch to be considered for the selection.
- c) One family from each branch will be selected randomly by the Branch Manager to be eligible for the prize.

2.3 **Selection Process**

- a) One eligible family per branch will be selected randomly by the Branch Manager.
- b) The selection will take place during the campaign period, and a new 'Ethera Udana' PFC Minors' Savings account needs to be opened to be eligible for the prize.

2.4 Prize Details

- a) The selected family will receive LKR 5,000 worth of cash or People's Bank Gift Vouchers.
- b) The prize will be awarded at the time of opening the new account.

2.5 **General Conditions**

3. "Vanitha Pranama"- Remittance Promotion Campaign

Methodology/Terms and Conditions

3.1 **Campaign Period**

The "Vanitha Pranama" campaign will be conducted from **2025.03.01 to 2025.03.31**.

3.2 **Eligibility Criteria**

- a) The beneficiary must be a **female account holder** of People's Bank.
- b) The Workers' Remittance must be credited directly to a **personal account** (FC/LKR) maintained at People's Bank.

3.3 **Selection of Winners**

- a) **Top 10 winners** will be selected based on the **highest value of Workers' Remittances received** into People's Bank accounts within the campaign period i.e. 2025.03.01-2025.03.31, where the beneficiary is a female.
- b) The remittances must be received during the **campaign period** (from **2025.03.01 to 2025.03.31**).

3.4 **Prize Details**

Each winner will receive LKR 50,000 worth of cash prizes.

3.5 **Exclusions from Eligibility**

- a) Remittances received by **non-female account holders/ Joint Accounts** are not eligible.
- b) **Employees of People's Bank** are not eligible to participate.
- c) Remittances received via drafts, TCs and currency notes are not eligible.

3.6 **General Conditions**

4. "Kalin Awrudu Vaasi"- Remittance Promotion Campaign

Methodology/Terms and Conditions

4.1 <u>Campaign Period</u>

The "Kalin Avurudu Vaasi" campaign will run from 2025.01.01-2025.03.31.

4.2 Eligibility Criteria

Only **Inward Workers' Remittances** received directly into **People's Bank FC and LKR accounts** (personal accounts only) during the campaign period will be eligible for the prize draw.

4.3 **Prize Details**

25 winners will receive LKR 25,000 worth of bags of essential goods for each.

4.4 Selection Process

Winners will be selected randomly by a draw for the beneficiaries who receive Workers' Remittances directly into their People's Bank accounts (FC/LKR) for the period from 2025.01.01 to 2025.03.31 and award each winner a Bag of Essential Goods worth LKR 25,000/-.

4.5 **Exclusions**

a) Remittances received via **drafts**, **TCs**, and **currency notes** are **not eligible** for this campaign.

5. 'Shrama Harasara" PFC Accounts Promotion Campaign

Methodology/Terms and Conditions

5.1 **Campaign Period**

The "Shrama Harasara" campaign will be conducted from 2025.05.01-2025.05.31.

5.2 Eligibility Criteria

- a) Only **new Personal Foreign Currency Savings accounts** that are **opened during the campaign period** from **2025.05.01 to 2025.05.31** will be considered.
- b) The selected customers must be **expatriates** who have never had a PFC account with People's Bank.

5.3 **Selection of Winners**

Eligible Customers who open a new PFC account in the month of May will receive a cash voucher worth Rs. 5,000/-. Branch Managers will randomly select winners who is eligible for the Prize.

5.4 **Prize Details**

Each winning customer will receive LKR 5,000 worth of cash or People's Bank Gift Vouchers.

5.5 **Remittance Requirements**

Remittances must be credited to the newly opened account within a reasonable time frame.

5.6 **Exclusions**

Customers who already hold a PFC account with People's Bank are **not eligible** for this campaign.

5.7 **Exclusions from Eligibility**

Employees of People's Bank are not eligible to participate in this campaign.

5.8 **General Conditions**

6 "Sanwathsara Pranama"- Remittance Promotional Campaign

Methodology/Terms and Conditions

6.1 Campaign Period

The "Sanwathsara Pranama" campaign will be conducted from 2025.01.01-2025.06.30.

6.2 Eligibility Criteria

- a) The remittances must be **Inward Workers' Remittances** credited directly into **People's Bank individual FC/LKR accounts** (personal accounts only).
- b) Only remittances received during the **campaign period** (from **2025.01.01 to 2025.06.30**) are eligible for the prize draw.

6.3 **Prize Details**

- a) A total of **64 winners** will be selected randomly by a **draw for beneficiaries who receive Workers' Remittances directly into their People's Bank accounts (FC/LKR)** for the period from 2025.01.01 to 2025.06.30.
- b) Each winning customer will receive a bag of essential goods worth LKR 15,000.

6.4 **Selection Process**

- a) Winners will be selected based on **Inward Workers' Remittances** received directly into People's Bank individual **FC and LKR accounts**.
- b) The winners will be chosen by a **random draw** from the eligible participants.

6.5 **Exclusions**

a) Remittances received via drafts, TCs, and currency notes are not eligible for this campaign.

7 "Doo Daru Pranama"- Remittance Promotional Campaign

7.1 **Campaign Period**

The "Doodaru Pranama" campaign will be conducted from **2025.10.01-2025.12.31**.

7.2 **Eligibility Criteria**

- a) To be eligible for the draw a new "Ethera Udana" PFC Minors' account should be opened at a People's Bank Branch during the campaign period.
- b) The newly opened accounts must receive Inward remittances, eligible fund transfers, or AFT (Automatic Fund Transfers) from the parent's or guardian's account during the campaign period.

7.3 **Prize Details**

Winners will receive **pre-arranged "Ethera Udana" school equipment sets** worth **LKR 5,000** each.

7.4 Selection Process

- a) **Winners** will be selected **randomly by a draw** for Minors who open "**Ethera Udana**" **PFC Minors' accounts** during the campaign period.
- b) The Minors will be chosen for the draw based on their eligibility (i.e., accounts that have received remittances or transfers during the campaign period).

7.5 **Prize Distribution**

The **school equipment** worth **LKR 5,000** will be provided to each winner.

7.6 Remittance Requirements

Remittances/Fund Transfers must be credited to the newly opened account within the Promotional Period (2025.10.01-2025.12.31).

7.7 Exclusions

- a) Only **newly opened "Ethera Udana" PFC Minors' Savings accounts** are eligible.
- b) Accounts that are **inactive** or do not meet the campaign criteria will not be eligible for the draw.
